# The Council Recommendation on Vocational Education and Training

## 6 REFORM CLUSTERS

1) VET is agile in adapting to labour market changes

2) Flexibility and progression opportunities are at the core of VET

3) VET is a driver for innovation and growth and prepares for the digital and green transitions

4) VET is an attractive choice based on modern and digitalised provision of training and skills

5) VET promotes equality of opportunities

6) VET is underpinned by a culture of quality assurance

## 3 TRANSVERSAL PRIORITIES

Support sustainable partnerships for the governance of VET at national, regional and sectoral level, involving all relevant stakeholders

Make the best use of European transparency tools such as the EQF, ECTS, Europass, ESCO, core profiles

Make the best use of EU funds and instruments

## 3 QUANTITATIVE OBJECTIVES

The share of employed graduates from VET should be at least 82%

60% of recent graduates from VET benefit from exposure to work-based learning during their qualification

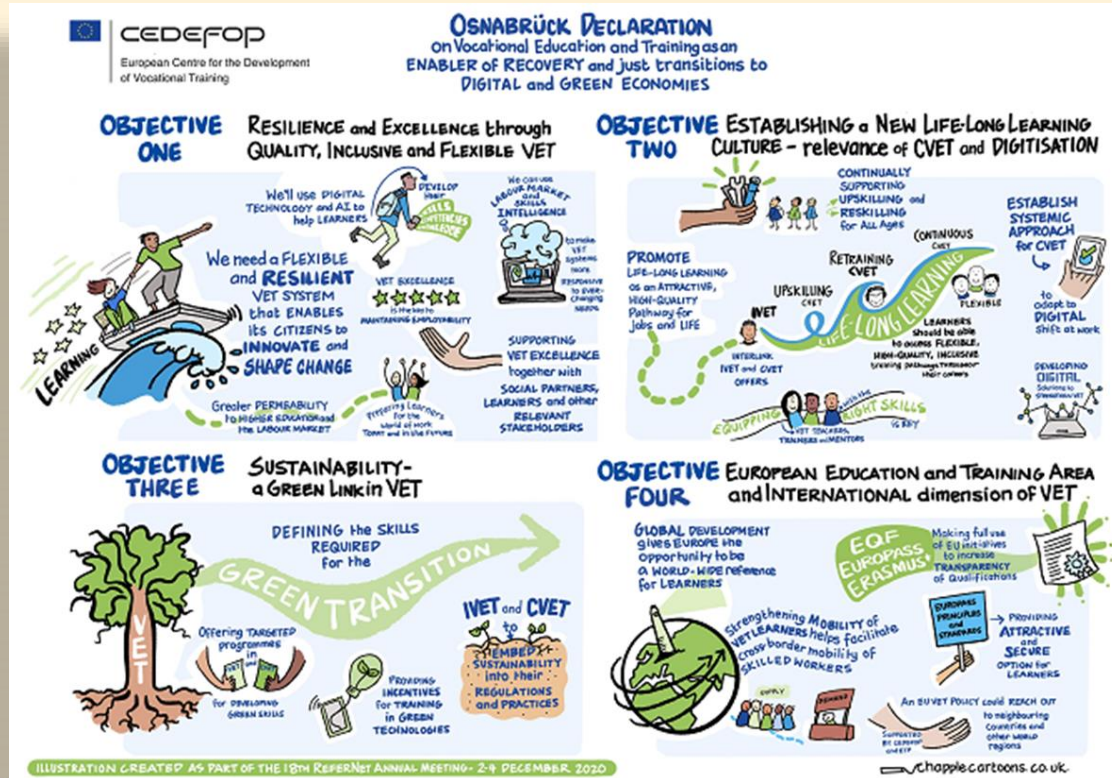
8% of learners in VET benefit from a learning mobility abroad

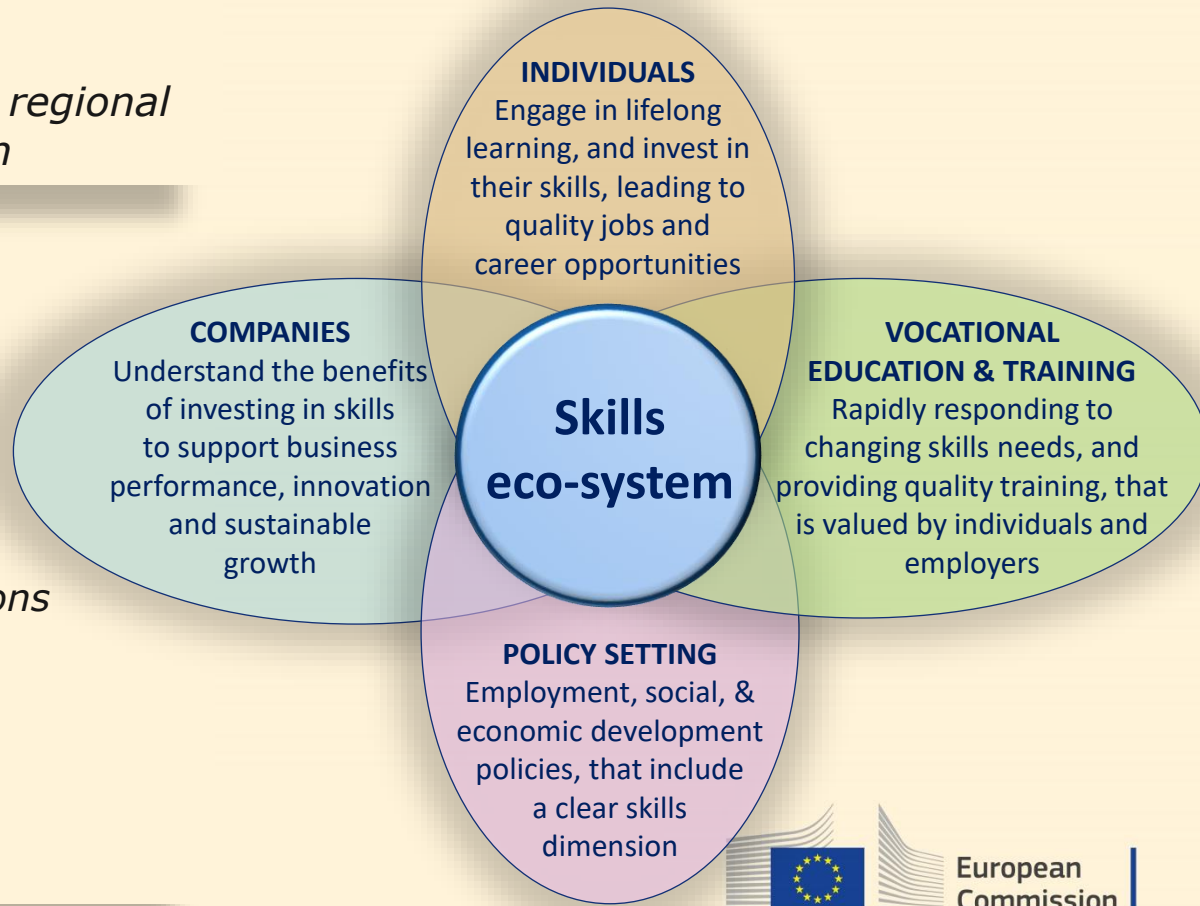

## *The initiative in a nutshell*

### The Goal

#### VET Excellence

- Innovative and responsive VET institutions capable of **rapidly adapting skills provision** to evolving economic and social needs, including the **digital and green transitions**

### The partners

**VET institutions**, Universities of applied science, Research centres, Companies, Chambers, Professional or sector associations, Trade unions, Policy makers, Employment services, Regional development agencies, Municipalities, Qualification authorities, and others

### How to get there

#### International collaborative networks of CoVEs

- **ACT LOCAL** – Establish strong local partnerships co-creating “**skills ecosystems**” for innovation, regional development, and social inclusion
- **THINK GLOBAL** – through **international collaborative networks** of CoVE in other countries to share experience and know-how, to foster mobility of learners and staff...

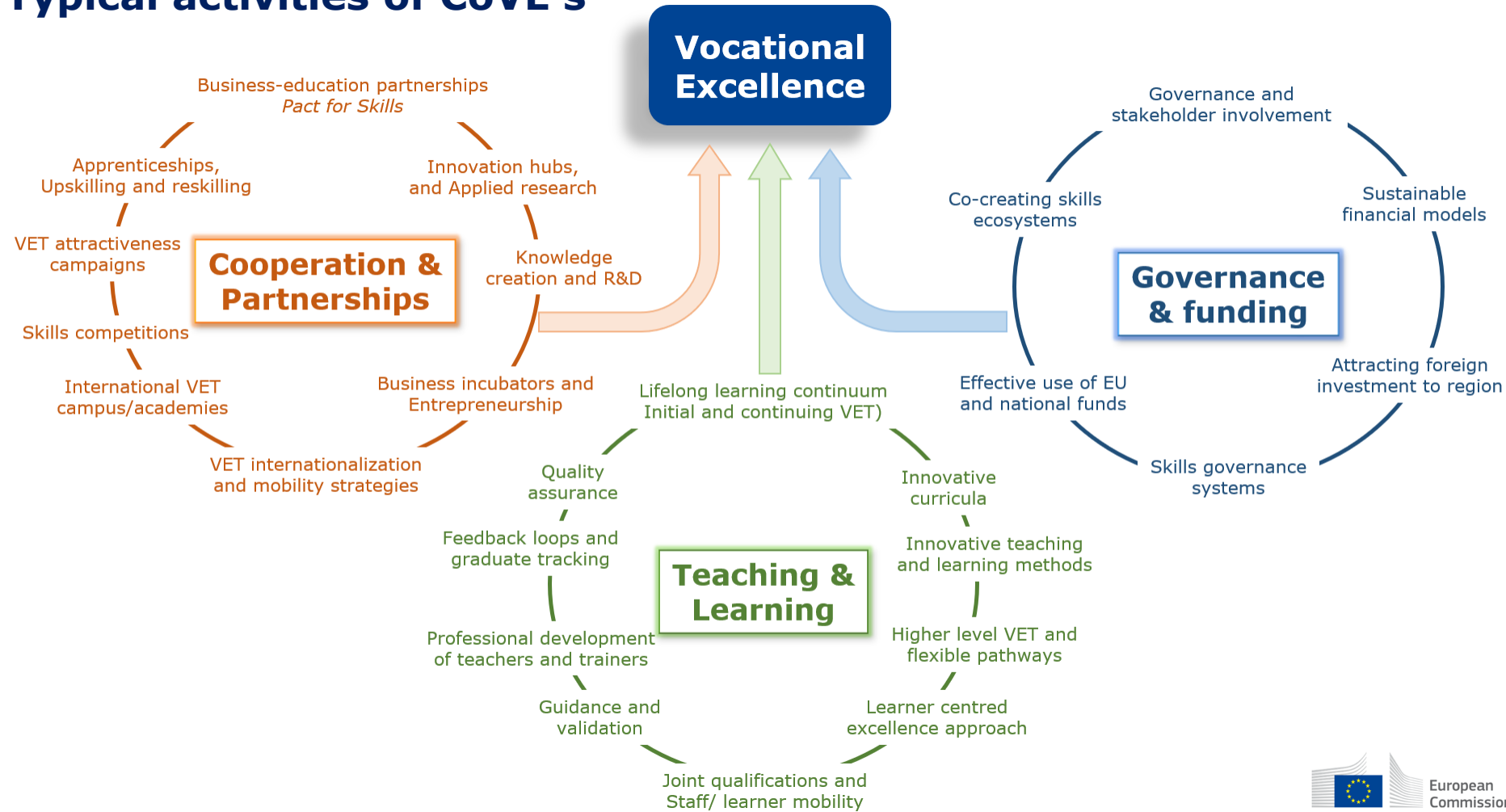
### EU Support

# Typical activities of CoVE's





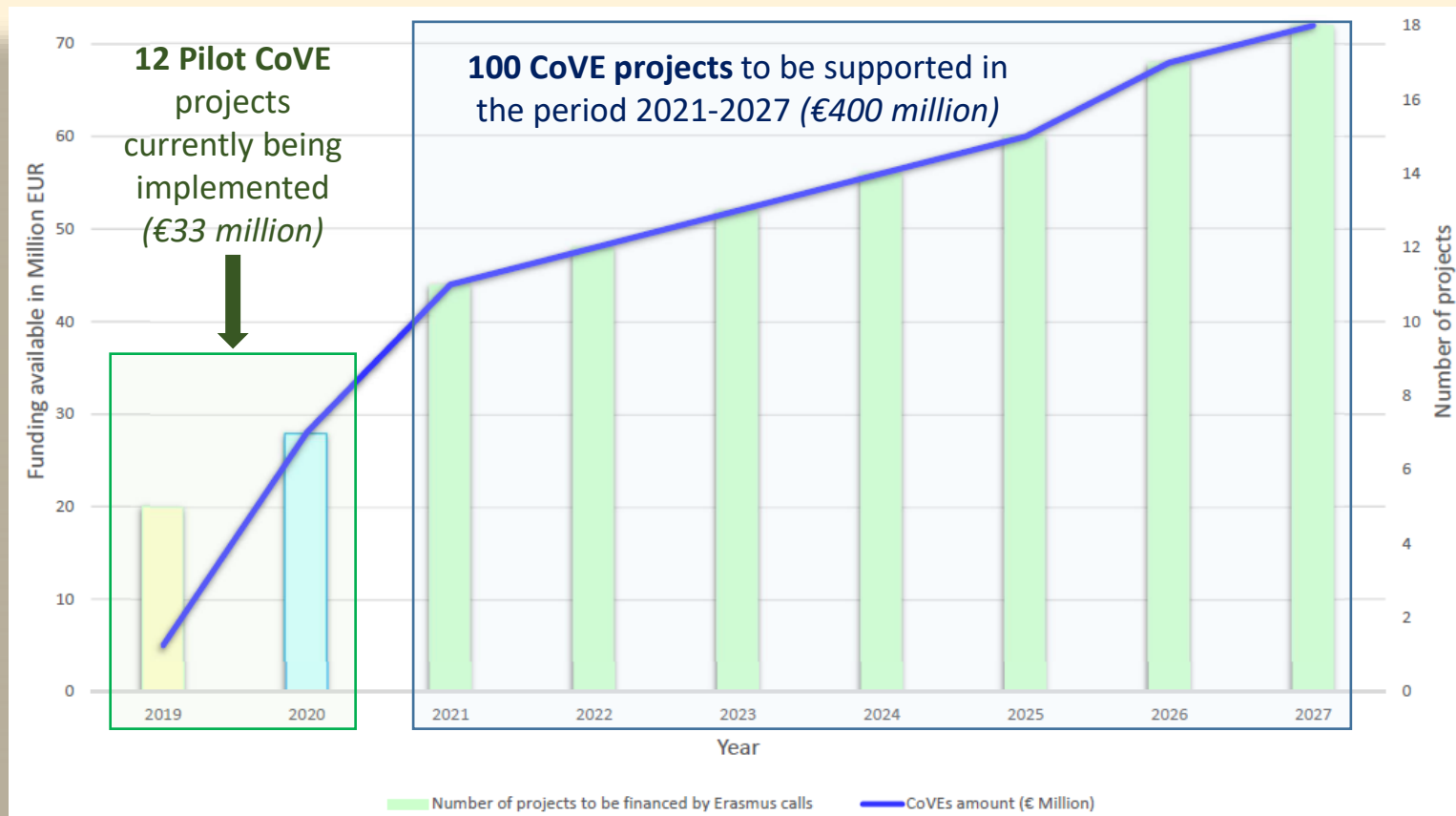
# Centres of Vocational Excellence

## *Erasmus+ funding under Partnerships for Excellence (Ka2)*

- **2021-2027:** €400 million for 100 networks of CoVE
- **Applicant:** Any organisation established in a E+ Programme Country
- **Partners:** Any public or private organisation active in field of VET, or world of work. Can be from any country in the world, but non-programme partners must bring an '**essential added value**'
- **Partnership:** at least 8 full partners from a minimum of 4 Programme
  - a) at least 1 enterprise, industry or sector representative organisation, and
  - b) at least 1 VET provider (at secondary and/or tertiary level)
- **EQF levels:** Can be at any EQF level but must include levels 3, 4 or 5
- **Maximum grant:** €4 million per project with 4 year project duration
- **Erasmus+ 2022 call:** Deadline for project applications **7 September 2022**

# **CoVE projects - Erasmus+ 2021 call**

## **SECOVE - Sustainable Energy Centres of Vocational Excellence**

### **Aim:**

Establish a network of cooperation among CoVEs in 5 European countries, in the sector of clean and sustainable energy. The CoVEs will cooperate transnationally with each other through common structured forms of dialogue and communication

### **Objectives:**

- Target a wide range of groups in the area of sustainable energy: VET students and institutions, companies (both staff and managers), women across educational levels and sectors, policymakers
- Organization of impactful events: 28 local and transnational workshops, networking events, capacity building, transnational Conferences
- Training of adults in partner organizations
- Mobility of VET learners
- Summer VET academies for girls in secondary education

# **CoVE projects - Erasmus+ 2021 call**

## **PoVE - Platform of Vocational Excellence Water Scale-up**



### ***Aim:***

A joint initiative of 8 VET schools, 7 Water industry professionals, 4 academic partners and 3 support partners, to educate and train VET learners to become agile, digitally skilled and sustainable oriented water sector professionals

### ***Objectives:***

- Holistic approach to VET in the EU Water sector with a central role in regional Innovation Ecosystems, and partnerships between VET, research and the water industry
- Setting up and interlinking CoVE Water networks that operate on interregional level
- Drive innovation by developing Digital, VR learning materials and blended training
- Increase student's, teacher's and professional's competence through international mobility
- PoVE Water as a worldwide point of reference for VET in the water sector
- Raising the attractiveness of the Water sector

***Project duration:*** 4 years

## **CATALYST - Sustainable Systems and Business Transformation**

### **Aim:**

Contribute to the European Green Deal and the new Industrial and SME Strategies. Establishment CoVEs in 5 countries and create educational offer for personal and organisational development, enabling SMEs to re-think and re-design their business models

### **Objectives:**

- Establish 5 CoVEs and a network anchored in a European VET eco-system
- Implement VET trainings, pilot-project with SMEs and applied research projects in selected sectors according to the national S3
- Co-create and disseminate applied knowledge inspiring business-education partnerships involving students, professionals & SMEs
- 70 VET courses for up-skilling professionals and students
- Raise demand and attractiveness of VET

# CoVE projects - *Erasmus+ 2021 call*

## *EULEP - innovative transnational C-VET training in AI, VR, & social innovation*

### **Aim:**

Make C-VET more attractive for lifelong learning, offer businesses new and tailor-made training modules that correspond to their skills needs in innovation-oriented subjects (artificial intelligence, virtual reality and social innovation)

### **Objectives:**

- Establish or reinforce knowledge triangles at regional and national level, through the triangulation business - VET provider - European Digital Innovation Hub (EDIH)
- Embed VET in regional economic development strategies and reinforce its governance
- Involvement of 500 companies in different activities including skills intelligence
- Regional VET Councils designing VET strategies and dissemination plans
- Online learning platform for VET providers
- European Learning Academy for training of VET trainers
- Regional multiplier events, and VET promotion campaigns
- Project management templates, tools and methodologies for training modules creation and teaching
- Transnational VET modules development, a guidebook for SMEs, EDIH partnership MoUs

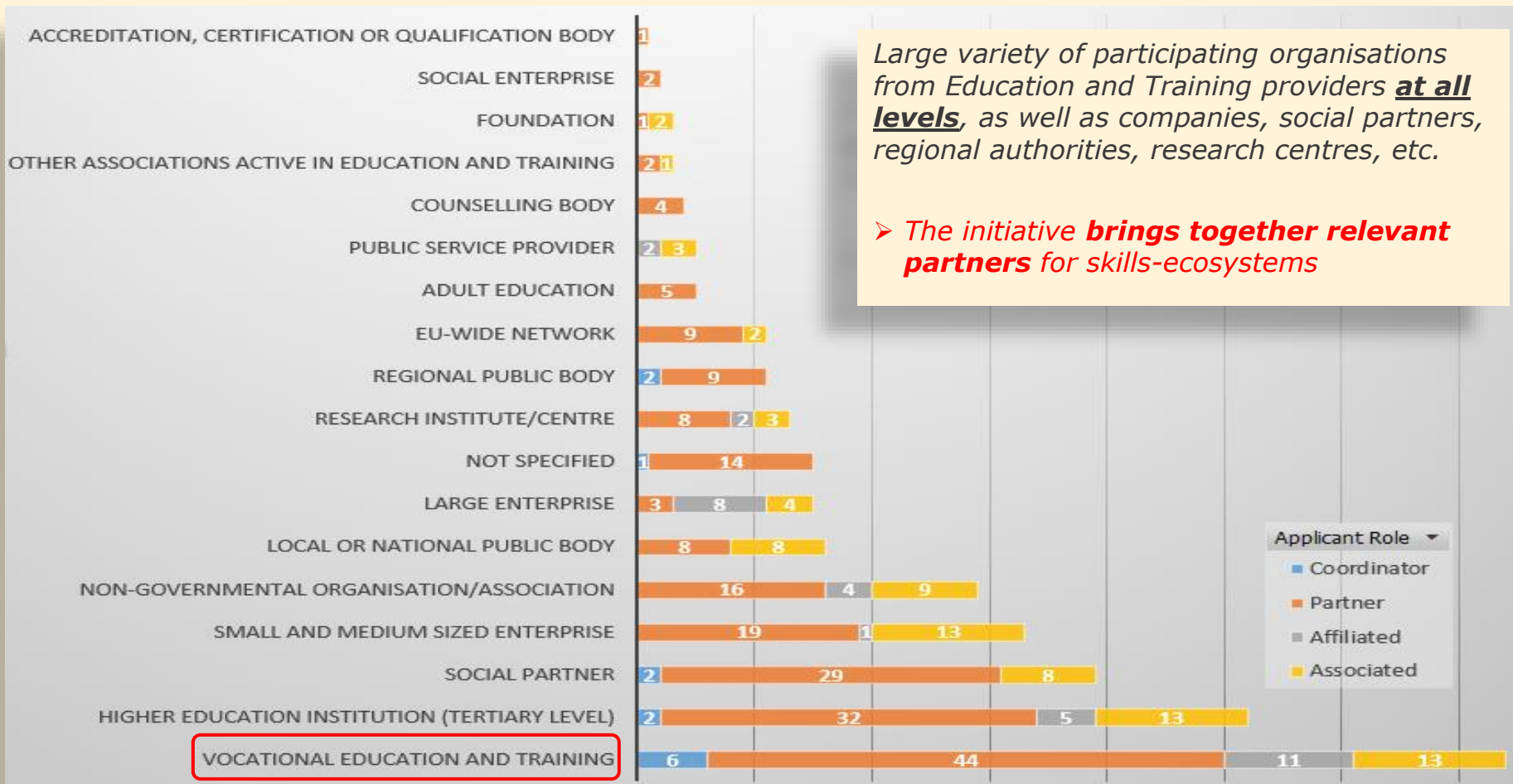
# CoVE Erasmus+ call 2021: Countries of participating organisations

**13 projects selected for funding** (84 projects submitted)  
**Grants approved €46 million** (grants requested €283 million)  
**37 countries in projects approved** (55 in project applications)  
**331 participating organisations** in projects approved
